

ABOUT US

The Victorian Rabbit Action Network (VRAN) was established in 2014 to promote community-led action for more sustainable and effective rabbit management in Victoria. Under the direction of a Board, VRAN operates as a partnership between community representatives, industry and government agencies.

VRAN's goal is to be a catalyst for change in how rabbit management occurs in Victoria. By 'helping people, help the land', VRAN wants to create a strong collaborative culture in Victoria whereby local communities can successfully manage rabbits in their area.

VRAN pursues this goal by acting as a facilitating institution that enables the full participation and recognition of community, First Nations, government, scientific and industry groups that have a stake in the problems caused by rabbits, and the co-design and delivery of initiatives and programs which can address the problems.





OUR FOCUS

Five Objectives

VRAN is focused on identifying and responding to opportunities to support communities and institutions to be knowledgeable and capable to deal with rabbits wherever they occur across Victoria.

VRAN is guided by five objectives:

- 1. Increase land managers' awareness and use of bestpractice rabbit management information.
- 2. Increase the level of community participation and effectiveness in on-ground rabbit control across Victoria.
- 3. Establish a state-wide network of community, industry, science and government participants with rabbit control expertise.
- 4. Build state-wide leadership and expertise in sustained integrated rabbit control.
- 5. Be a well-governed and resourced organisation.

PARTNERSHIP AGAINST PESTS

From the very beginning, Agriculture Victoria has been supporting VRAN by providing funding as well as executive and project officer support. I'd like to welcome Nicole Garfi, Martin Deering, Barton Roberts and Paul Major who will be helping VRAN to implement our strategic initiatives in 2023/24.

OUR REACH

Our annual training program continues to build new relationships, confidence and knowledge for people working in the field of pest management. We have delivered two Rabbit Bootcamps in 2022, held at Macedon and Queenscliff. To continue providing support to participants after the course the VRAN Mentors also delivered several learning network sessions. These sessions provide an interactive platform where people can continue to exchange knowledge and ideas and grow relationships.

In 2022, we also formed a new partnership with Bilk, who are the NRM team of Taungurang Land and Water Council. VRAN Mentors and Bilk codesigned an engaging professional training program to increase the knowledge of their team and their participation of their organsiation in rabbit management to help assist in the caring and healing of Taungurung country.

This project also provided an opportunity for VRAN and Biik to collaborate with other community groups working to protect and conserve the natural and agricultural landscapes and included Cathedral Landcare group, Granite Creek Landcare and Euroa Arboretum. VRAN look forward to continue working with the Biik team in 2024.








Participant Map

PROGRAM:

BIIK PROGRAM

This program was delivered on Taungurung Country. It was co-designed for professionals working in NRM roles for First Nations enterprises.

SNAPSHOT

- Aim: Bilk want to increase their rabbit management knowledge and improve their practices that will benefit Country for all.
- Partners: Biik & VRAN
- Timeframe: 2022-2023
- Funding Partner: Biik and Agriculture Victoria
- Taungurung locations: Alexandra, Buxton, Euroa, Gooram and Taggerty.

Biik is the Taungurung word for Country.

Biik is an enterprise established by Taungurung Land and Waters Council (TLWC), to provide cultural and natural resource management (CNRM) services right across Taungurung traditional country. Together VRAN and Biik co-designed, a fun and engaging course with a mix of classroom and field sessions held on Taungurung Country.

We shared and exchanged knowledge on best practice rabbit management, cultural heritage and what it means to read, heal and care for Country.

The VRAN mentors continued to provide peer support to five Bilk staff for 12 months. Sessions focused on hands on learning, mentoring and community engagement.

The course also increased engagement opportunities with First Nations enterprises. Biik networked and collaborated with Cathedral Landcare, Granite Creek Landcare, Alexandra Historic Railway, Michael Kaponica and Euroa Arboretum.
